COMMITTEE ON PUBLIC UNDERTAKINGS

Constitution of the Committee:

The Committee consists of thirteen members of whom nine members are elected from amongst the members of the Legislative Assembly and four members are elected from amongst the members of the Legislative Council. They are elected according to the principle of proportional representation by means of single transferable vote and in accordance with the regulations framed in this behalf by the Speaker.

Process of election :

A motion is moved in the Legislative Assembly calling upon the members of the House to elect from amongst themselves to

the Committee on Public Undertakings. After the motion is adopted, a programme fixing the date for filing nomination, withdrawal of candidatures and the election, if necessary, is notified or announced. On receipt of nominations, a list of members who filed nominations is prepared and displayed on the notice board. If number of members nominated is equal to the number of members to be elected, the members nominated are declared elected after the expiry of time for withdrawal of candidatures. If number of members nominated after the withdrawals is more than the number of the members to be elected, election will be held on the stipulated date as is mentioned in the programme. The results are announced after counting.

Appointment of Chairman:

The Chairman of the Committee is appointed by the Speaker from amongst the members of the Legislative Assembly elected to the Committee.

Minister not to be a member of the Committee :

A Minister is not eligible to be elected as a member of the committee, and if a member, after his election to the Committee, is appointed as Minister, he ceases to be a member of the Committee from the date of such appointment.

Term of Office :

The term of office of the members is one year. There shall be a fresh election before the end of the financial year for constitution of the

Committee for the ensuing financial year. If under any circumstances such election is not held, the existing members of the Committee will continue to hold office until new members are elected.

Functions of the Committee:

The Committee on Public Undertakings examines the work of the Public Undertakings mentioned in the Annexure and such other Public Undertakings as may be specified by the Speaker from time to time.

It examines the reports and accounts of the Public Undertakings and also examines the reports, if any, of the Comptroller and Auditor-General on such Public Undertakings.

The Committee examines in the context of the autonomy and efficiency of the Public Undertakings whether the affairs of the

Public Undertakings are being managed in accordance with sound business principles and prudent commercial practice.

Selection of subjects for examination:

The Committee on Public Undertakings selects for examination such Public Undertakings which are figured in the Audit Reports. It may select on its own certain undertakings basing on Audit Reports.

The Accountant-General assists the Committee in the examination of Public Undertaking.

The Committee calls for information from the Departments concerned in regard to subjects selected by it for examination. The Committee may make ‘on the spot study’ and take evidance of the officials concerned with the subjects under examination.

Report :

The Committee concludes its examination on the subject and prepares a report with its conclusions. After the Committee adopts the report, it is presented to the Legislature.

Action taken on Reports:

After the report is presented to the Legislature, it is sent to the Department concerned to take action on the recommendations contained in the report. The Departments have to furnish action taken replies within six months from the date of despatch of the report to them thereon. The Committee examines such reports and presents its report to the Legislative.

Declaration of Interest by the Member in Committees:

Where a member of a Committee has personal, pecuniary or direct interest in a matter which is to be considered by the Committee, he/she shall state his/her interest therein to the Speaker through the Chairman of the Committee, by means of an affidavit.
